Superintendent

Highlights of the Superintendent's Report as follows:

- 1. Welcome Back. Outlined the work over the summer preparing the buildings, hiring staff and establishing professional development opportunities for the year.
- 2. Highlights of programs for the students and staff include:
 - adopted and implemented rich curricular resources in ELA and Math, K-12,
 - offering more advanced placement programs opportunities for our students,
 - expanding opportunities for acceleration and advancement at the Middle School,
 - reinstated the 9 period day at the secondary level;
 - outstanding and award-winning arts and music programs, athletics programs, and our studentathletes are as often recognized for their sportsmanship and scholarship as they are for their performance on the field or court;
 - implementing a new Independent Science Research program,
 - implementing a robotics program,
 - increasing opportunities for our students to earn college credits through partnerships with colleges and universities, including SUNY Farmingdale, SUNY Stony Brook, Syracuse University, and our local community colleges, to name a few.
 - We have an outstanding summer enrichment program for our K 6 students, which include ELA and Math enrichment, exploration opportunities in science, the arts, and music.
 - We have partnered with Columbia University Teachers' College and Reading and Writing Workshop program and our teachers began working with our partners this summer to implement this program.
 - We have partnered with the Urban Learning and Leadership Center to engage in the work of continuous school improvement;
 - Over eighty graduating seniors of the Class of 2015 received more than 200 scholarships and awards at the high school's annual Senior Awards Ceremony last year, and the Class of 2015 received over 1.5 million dollars in scholarship money. Our seniors have also been accepted to top colleges in the region and in the country, including: Columbia, New York University, SUNY Binghamton, SUNY Stony Brook, SUNY Albany, Hofstra, Howard, and Marist, just to name a few.
 - We have worked together to improve our facilities and are continuing to do so through the development of a bond referendum initiative;
 - We have implemented improvements to security and safety and continue to study and evaluate these areas to ensure our schools are safe learning environments for students and staff;
 - We've implemented a new academic eligibility policy at the secondary level to provide support for our athletes and student participants in extra-curricular activities which allows our students to stay focused on the importance of academic performance;

- We've seen some modest gains in the graduation rate and the 3-8 assessments, and more of our students our taking advanced Regents courses.
- 3. Highlights of achievements/upcoming events of students and staff include:
 - One of our seniors, Tysheem Griffin, qualified to compete in the 2015 INAS Global Games in Ecuador.
 - Senior Amanda Boegel will perform the Star Spangled Banner at 9/11 Ceremony in the Village and Joseph LaManna will play taps.
 - 2nd Vice President, Jeannette Santos, received the Community Service Ambassador Award from In the Word Ministries.
 - A thanks to Bob Claps and Carol Seehof for the ATA's annual Back to School Backpack and School Supplies Bash.
 - This morning the Historically Black College Tour began their tour of various colleges.
 - The Administrators participated in a Leadership Retreat with the Urban Learning and Leadership Center to focus on long-term strategic planning analyzing the district mission, goals and belief statement, developing a five year strategic plan. Our theme is Planning for Excellence relating to student achievement, school culture and community relations/involvement.
 - Planning is underway for the first Community Forum where information gathers will be used to inform the development of the District's Strategic Plan.
 - October 2, 2015 the Amityville Sports Hall of Fame will be held at the AMHS
 - October 3, 2015 the Homecoming Parade begins at 1:00 p.m. and the game against Rocky Point will be at 3:00 p.m. This year, for the first time, each of the schools Grades 9-12 will have floats.
 - The APTC is hosting a fundraising event at Five Guys on September 28th from 4-10 p.m.
