# **PRESENTATIONS**

1. Budget Workshop #3 – Capital Component

Board questions regarding presentation:

2. non instructional clerical - we budgeted \$49,972, same as last year and YTD we have spent \$15,807. There will be an increase in staff to accommodate the paperwork, purchase orders as the bond work begins.

- 3. does the custodial overtime connected to snow removal. Snow removal is a separate line, this includes employees out sick, vacation, workman's compensation cases where we need to bring in substitute custodians.
- 4. The budget for natural gas vs oil. The oil is in case the heating system fails, it's a back up.
- 5. Any funds budgeted for and not used to transfer to the reserve fund.
- 6. We will start doing asbestos testing and abatement and go through WSBOCES to get some aide back
- 7. The maintenance staff was increased by .5 FTE to bring repairs in house and not contract out.
- 8. The question came up again why we have a maintenance repair budget and the bond issue. Again it was explained the maintenance repair budget is for day to day operational repairs such as plumbing, electricity for the air conditioners, bathroom tile replacement, maintenance of the kitchens and heating systems, etc. The bond is for the reconfiguration of existing building and improvement of structure, adding wings to accommodate the increase of enrollment.
- 9. The process for building the budget starts with the Principals and Directors and a review of their perspective buildings in what the short term repairs, needs for the students' academics, etc. It is based on last years expenses and the anticipation of the aide the state allows. The requests include a "wish list" and prioritize the immediate needs of the building and/or department. It is a collaborative effort.
