REPORTS

Dr. Kelly, reported that she is looking forward to a fabulous 2018-19 school year. The Administration and the School Board toured the Buildings with Mrs. Freifelder and Mr. Dziedzic and found that the buildings were ready to receive children last Tuesday. We had a smooth opening except with regard to some issues with transportation, which will be resolved for next year. Dr. Kelly also reported on the Strategic Plan for the 2018-19 school year for the success of the students. Dr. Kelly thanked the ATA for the success of the Back to School Bash. She also discussed a Senior College Night at the High School.

The APTC will have a party at 5 Guys. Please consult the website for upcoming events. Dr. Kelly also introduced 2 members of our staff who have been appointed to new positions at the Edmund J Miles Middle School; Earl Mitchell and Paul Duguay.

COMMUNITY COMMENTS ON NON AGENDA ITEMS

Nadra Lanham, was following up on the August 30 meeting, and asked if there was going to be a committee on why we lost so many administrators, and the hiring process. Ms. Dodd responded that that wasn't discussed on August 30. Dr. Kelly will share that information with Ms. Lanham.

Sandy Satziga stated that she is still have transportation issues. She asked what is the proper channel to commutate issues with the district. Dr. Kelly responded that Ms. Herrero is the point of contact. Ms. Satziga also asked why are we transporting a student to Bethpage, what is the allotted legal time a student can be on the bus and who is responsible for the transportation office? Dr. Kelly responded that she was responsible. Ms. Freifelder responded that sometimes bus companies do pick up students from other communities attending the same private school.

Jack Magnani stated that his son is in Pre K and there are students that are on the bus for over an hour.

Brenda DiPaola stated that her daughter also goes to Sacred Heart, and the driver is taking her to school too early because he needs to get to another route.

Karen White stated that most of her bus issues with Kellenberg have been resolved. She also stated that we need a communication system. Ms. Freifelder stated that we are reaching out to all the parents with a letter that asks for additional information. Regarding communications. Ms. White stated that she lives on East Lake Drive and shared that a fork lift showed up and moved all the pots that had closed off an entrance to the high school. By removing those flower pots that gate to the rear entrance to the high school has been opened. How long will this be open? Dr. Kelly responded that she had met with the Village over the summer to keep everyone apprised about the construction at the High School. She further stated that she had met with the Village last week in order to have the rear gate opened for bus exiting only for thirty minutes in the morning and an additional thirty minutes in the afternoon. No cars will be permitted to use the gate. The Village gave the district a thirty-day trial period. The gate will be open and manned by our administrative and security staff for exiting of school buses only. Construction will be finished at the end of the 2019-20 school year. Ms. White also said that she observed cars and buses going through that gate very fast. Dr. Kelly responded that security and administrative team will be monitoring that gate.

Kerri Geiger asked, what percentage of school age students attending non-public schools use transportation? She also asked how much of the \$4 million line transportation item in the budget is allocated for the public school students? Is it safe to think that the remainder is for private schools? Is there any truth to a rumor that the Board of Education is considering taking away busing for non-public students? She further stated that her daughter who attend Holy Trinity is on the bus for well over an hour and gets car sick. She needs to know the route so she can get her off the bus at an earlier stop. Ms. Geiger has been driving all 3 of her children to school so they won't be late because when they do take the bus they are late. She asked for the bus stop to be changed and yes it was done, but nobody told them so the children were at the wrong stop. The main problem is that the Holy Trinity Bus her daughter is taking requires her to walk in the dark alone. They did change the stop but nobody told us. Ms. Geiger's daughter called her from the bus which was not air-conditioned and was so sick she wanted to throw up in her book bag. We should have 2 mini buses going to Holly Trinity. We deserve better. Dr. Kelly responded that we did address some of these problems last week and you deserve the best service that we can provide.

Susan Heenan stated that the August 30 meeting was held on a Thursday, why wasn't it held on the usual Wednesday? Ms. Dodd responded that it was a Special Meeting that was called and there were many things going on that week, and we made the discussion to hold it that night. Ms. Heenan asked to see the evaluation of the Superintendent. Ms. Dodd responded that you may Foil the evaluation. Ms. Heenan asked Dr. Kelly and the Board of Education what their goals were for this year? Ms. Dodd stated that you can put your request in writing. Dr. Kelly responded that she would be happy to share the goals with Ms. Heenan. Ms. Heenan asked what the salary was for the Superintendent before the raise? Ms. Dodd responded that Dr. Kelly's salary was

\$215,000 for the past two years. Ms. Keenan asked if the raise starts after her current term? Ms. Dodd responded the raise was retroactive.

Ms. Keenan asked when the district is receiving the Chromebooks from the grant? Dr. Kelly responded that we are hoping to have them by Thanksgiving.
